3. The vendor will receive 60% of the total price of the item sold.
4. We have a reputation for selling high quality merchandise and require all items to be **CLEAN** and free of stains. Dirty, stained and/or ripped clothing will NOT be put out for sale. We reserve the right to refuse items that are in poor condition or deemed unsellable by GKSS.
